Revelation 13:8 shows Jesus' sacrifice as the strategy of first attack, "And all that dwell upon the earth shall worship him, whose names are not written in the book of life of the Lamb slain from the foundation of the world." Add "precluding [disqualifying] debate or expostulation [express disagreement, not admitting of question or appeal, positive, absolute, decisive, conclusive, final," as described by *Webster's Revised Unabridged*. Arrangements were made well advance when we had a debt that we could not pay. Jesus paid it all. Covered!

A COVENANT NEVER VIOLATES ITS VOW TO EXTEND FULL COVERAGE

Account 1: God ordained Hosea to marry Gomer—a prostitute, illustrating just how far the Lord's love and mercy will go. Although the bride price was less than that of a slave, Hosea redeemed her when she was later sold into slavery still showing her worth. That door of hope brought Gomer out of the trouble she caused to be refreshed to have only one desire, the Lord. Account 2: Prior to Boaz being considered a redeemer, he made continuous appeals to Ruth to receive out of his portion; as he increased his giving to Ruth, her capacity to receive was enlarged until she was motivated to make an offer for him to cover her with his best portion. Ruth returned home with the promise of redemption, Naomi responded, "Now you must wait, daughter. We must wait and see what happens. Be at peace. That man will not rest today until this is resolved," Ruth 3:18, The Voice. After trouble ambushed them, a door of hope was opened when the Boaz—a mighty man of wealth—promised he would make necessary arrangements for a redeemer or do the honors himself. In the end, Boaz purchased Naomi's husband's land and took Ruth as his wife; he redeemed them from poverty when they were left without provision after their husbands' deaths. Account 3: Jesus Christ redeemed us so we would never be separated from him again. United as one flesh. With the grave stone rolled away, the door of hope was left wide open for the Church —the bride of Christ—to come into his presence with greater intimacy, an entrance never to be sealed again. "And this is the reason a man leaves his father and his mother and is united with his wife; the two come together as one flesh. There is a great mystery reflected in this Scripture, and I say that it has to do with the marriage of the Anointed One and the church. Nevertheless, each husband is to love and protect his own wife as if she were his very heart, and each wife is to respect her own husband," Ephesians 5:31-33, The Voice. In each case, the wife's strengthened position improved her level of provision; weakness never diminished it.
